ADDENDUM AGREEMENT
MARCH 2012

Reference is hereby made to an agreement entered into between ITV Studios Limited; STV Productions Limited; ITV Network Limited; The Writers' Guild of Great Britain; and The Personal Managers' Association (the "**Agreement**") for Drama Commissioned by ITV Network Limited and other broadcasters.

It has been agreed that in summary the following changes shall be made to the Agreement:

1. The following category of repeats shall be added to the existing "REPEATS" section of Schedule B in the Agreement:

Shoulder Peak Plus: 22.00 – 22.30 30%*

*Shoulder Peak Plus: Only applicable for programmes that commence in the time slot 22.00 – 22.30 and run beyond 22.30 (i.e. a 30 minute programme commencing at 22.00 and ending at 22.30 would not qualify for Shoulder Peak Plus)

2. The following term shall be added to the existing "REPEATS" section of Schedule B in the Agreement:

Regional Repeat:

It has been agreed that in the event that a programme is repeated on STV North/South the payment due shall be 25% of the relevant repeat fee.

3. It has been agreed that the following Clause shall be deemed to replace the existing "ITV2, ITV3, ITV4, MEN & MOTORS and all other ITV digital channels" in the "REPEATS" Section of Schedule B in the Agreement:

ITV2, ITV3, ITV4, MEN & MOTORS and all other ITV digital channels

As of May 2011, for sale to ITV digital channels during the ITV1 licence period the Writer shall receive a 10% share of the gross sales price received by ITVS or STV.

It has been agreed for a sale to ITV digital channels outside the ITV licence period the Writer shall receive a 5.6% share of a percentage of the "Programme Licence Fee" according to a rate card published by ITV. For a sale to a Digital Channel other than an ITV digital channel the Writer shall receive a 5.6% share of the gross sales price received by ITV or STV.

4. It has been agreed the minimum script as set out in Schedule B shall be:

MINIMUM SCRIPT COMMISSIONING FEES

Original Teleplay rate*	£12,650 (twelve thousand six hundred and fifty pounds) per hour slot length (pro rata)
Series and Serials	£9,900 (nine thousand nine hundred pounds) per hour slot length (pro rata)
Long Running Series**	£3,300 (three thousand three hundred pounds) per half hour slot length (pro rata)


*including as possible pilot for series/serial

** Long Running Series are defined as: having 13 + episodes; and
 being pre-approved by the Forum

Except as expressly supplemented by this Addendum, all the other terms of the Agreement shall remain in full force and effect. Save where otherwise defined in this Addendum, all terms shall have the meaning given to them in the Agreement.






