Agreement between the UK Theatre and the Writers' Guild of Great Britain and the Scottish Society of Playwrights

The Writers' Guild has agreed an increase in the minimum fees paid by subsidised theatres of **6% from 1**st **May 2023** and a further increase of **4% from 1**st **May 2024**

Clause 2 (a) Commissioned Play

(i) on signature of Contract (such sum not to be on account of royalties) the minima under this sub-clause are:

Clause 5 (b) Rehearsal Attendance Fee

The Writer shall be paid not less than the following sums for each day the Writer attends the theatre under Clause 5(a) or carries out re-writes or research away from the theatre or other work in connection with the Play, provided that such attendance, re-writing, research or other work shall be mutually agreed between the Writer and Manager. Otherwise, the Manager shall not be obliged to pay for the Writer's attendance for rewriting, research or other work for more than twelve days during the rehearsal period.

Clause 16 Management Participation

The Management Participation Threshold from May 2023 is £40,779.47 and from May 2024 is £42,410.65
